**Post dated checks for the 2nd and 3rd installments are due with contract on June 1, 2010, if the contract is not paid in full at the start of the contract.**

Checks will not be cashed before the first day of the contract period. All outstanding bills must be paid in full before a contract will be accepted.

Once the contract period has begun, there will be **no refunds, except in the case of injury**. Changes in days and session times contracted will be considered depending on space availability. The fee for changing your contract is \$25 and is limited to twice during the contract period. There is no fee for additional sessions.

Please keep a copy of your contract for future reference.

- **Selling ice:** Write your name on the ice sheet under sell. Club ice must be sold FIRST. If Club ice is sold, buyer then will put her/his name under Buy and will write a check to the next available name under Sell. Place check in skater's folder. You may also sell your ice by calling the Club phone 952-832-0228. State your name, today's date, and the date(s) and time(s) of the ice you want to sell.
- **Injury Guidelines:** Skaters will receive a 75% refund for contracted ice AFTER 2 weeks of missed ice due to injuries. Requests need to include a doctor's order and coach's confirmation.
