**Post dated checks for the 2nd and 3rd installments are due with contract on June 1, 2011, if the contract is not paid in full at the start of the contract.**

Checks will not be cashed before the first day of the contract period. All outstanding bills must be paid in full before a contract will be accepted.

**Changing your contract**

- There are no refunds after the contract due date - June 1, 2011. (except in the case of injury). **You cannot drop sessions after this date.**
- Between June 13 and June 17 (end of the 1st week of contract), you can **change** sessions without a penalty, but you need coaches approval.
- After June 17, changes may be made with a \$25 change fee. Changes are limited to twice during the contract period.
- Additions to the contract may be made at any time with no fee.
- A revised contract needs to be submitted with changes.

**Other Notes**

- **Please keep a copy of your contract for future reference.**
- **Please arrive for your session 15 minutes before you need to be on the ice.**
- **Injury Guidelines:** Skaters will receive a 75% refund for missed contracted ice sessions AFTER 2 weeks of missed ice due to injuries. Requests need to include a doctor's order and coach's confirmation.
  - To qualify, the skater must have 2 continuous weeks away from skating due to injury.
  - After 2 weeks, if the skater returns on a reduced schedule due to the injury and recovery, all missed contracted ice will be reimbursed until the skater is back to full schedule.
  - Ice coupons do not qualify for refunds.
- **Member in good standing:** Home Club members must contract at least one session (or purchase one coupon book per contract) and have outstanding invoices paid to remain a member in good standing.
