

## FSC OF BLOOMINGTON'S GUEST COACH AGREEMENT

This form must be filled out completely and approved by the Figure Skating Club (FSC) of Bloomington Board of Directors before guest coaching is permitted.

### **Terms and Conditions**

1. I am a current member in good standing with US Figure Skating Association & the Professional Skaters Association (PSA).
2. I agree to familiarize myself with FSC of Bloomington policies, and to abide by them. All rules, regulations and policies of FSC of Bloomington are available on our website, [www.fscbloomington.org](http://www.fscbloomington.org).
3. I will return this Guest Coach Agreement to the Pro Ice Office at Bloomington Ice Garden at least one week prior to my first day of guest coaching.
4. I have purchased a liability insurance policy with amounts recommended by U.S. Figure Skating and I will provide a copy for the FSC of Bloomington to keep on file.
5. I will provide a copy of my membership cards for my associations to keep on file before the first day I guest coach.
6. I abide by the PSA Code of Ethics and Professional Conduct.
7. Solicitation of any kind will not be tolerated in the skating facility.
8. This agreement is valid for one year from time of approval.

10. This agreement may be terminated at any time at the sole discretion of the FSC of Bloomington Board of Directors.

**Agreement:** I hereby agree to the above terms as a condition of being granted guest coach privileges by FSC of Bloomington. I understand that any violation of the above terms, or any rule, regulation or policy of FSC of Bloomington may result in a loss of my privileges.

**Assumption of Risk and Waiver of Liability:** I am aware that figure skating is a dangerous sport, and that my participation as a guest coach with FSC of Bloomington is at my sole risk. I hereby agree to release, indemnify and hold harmless Figure Skating Club of Bloomington, and all of their directors, officers, agents, insurers, attorneys and employees from any and all claims, demands, losses, damages or injury, whatsoever, of any kind or nature, that I may sustain as a result of my participation or activities as a guest coach of FSC of Bloomington.
